

Practitioners and Some of the Authorities Who Were Told About the Brutal Torture at St Joseph's Hospital Nashua NH

None of these practitioners and authorities did anything. They were told prior to BD Hughes MD's arrest. I had repeatedly contacted the authorities in the state. I was told that victim, my mother, would have to do this and not me. This did not make any sense except that the 'authorities' did not want to do anything, to revictimize the victim.

An analogy to this would be witnessing a bank robbery and being told that what they had to say was not accepted as only the bank tellers getting robbed would be credible. What if the armed robber opened fire and killed all the tellers? What about all the victims of drug induced 'mental illnesses' not having any advocates in the facilities? I wonder how many hundreds if not thousands of patients at St. Joseph's Hospital, now Covenant Healthcare, have been given drugs to induce the symptoms of effective disorder, delusions and death? Other practitioners who witness this doing

nothing, and even ganging up against the patients who have been harmed? I can see that this is on going with how that I was treated at St. Joseph's Hospital Family Practice, Covenant Healthcare in Bangor. My medical records and news clips thrown out. Intentionally misdiagnosed as 'delusional,' when asking for someone to look at my symptoms.

None of the practitioners would even do a write up of how this effected me, or how medical environments effect me. So I have to relive this over and over, with every practitioner since. I can not have my life and get written up like another psych patient to get processed.

An analogy is the rape victim that gets repeatedly raped as by standers don't want to get involved and look at their feet. I want it to end! I don't want to suffer any more! I demand validation, a little respect, help to connect and justice!

Dr John Dunn (participant, gave my mother the ECT's against her will). Nashua NH

Dr. Martin Fleishman, (ME) saved my mothers life by getting her off of the anticholinergic drugs, but did nothing to contact the authorities as to what was being done to patients.

He had to be given a veiled threat to stop the Mellaril and give her another medication, Navane, which is less anticholinergic. She was disabled as the result of the torture and I had to care for ever since.

Maine State Troopers Michael Pratt and Dennis Hayden: They both took all my mother's medical records, were looking through them. They tossed them at me and they were ransacking my room for money that they felt was in the house. This was done during the home invasion/shake down for money.

Dr Trinkle, ME. Referred this discussion to my psychiatrist.

Nicholas Gess Assistant AG. Bangor Maine. He did nothing. What is weird with Gess is that later he was

an a lobbyist for defense companies. Yet, he was more interested in covering up dirty officers and withholding exculpatory evidence so that I could not defend myself. Or allow me talk about all the defense workers who were being drugged, sexually assaulted. The parents of kids were so drugged by Hughes and his cronies that they would talk about classified projects. The KGB would hang around in the bars and nightclubs in the area and pay for this information from disgruntled employees of Sanders, now BAE Systems.

Recently, mentioning anything about coming from a high tech/defense area in the nation, gets written up as 'hard to believe', 'delusional,' by 'quacktioners' in Bangor. Non stop culture destruction by the so called 'professionals,' as everyone gets the 'head case,' diagnosis.

1986 - People explained it to me that Nicholas Gess was as bad as the terrorist officers, Pratt and Hayden. All he was interested in burying the home invasion. To deny me the right to exculpatory evidence. That's why no one gave me a piece of chalk and access to a blackboard cause they knew that I was innocent. Dr Paul Goodman, ME. He saved my life. He saved my mother's life.

Dr Brian Roebuck, Spring Hill FL. Referred this discussion to my psychiatrist.

Dr Thair Dieffenbach. Spring Hill FL. Dr Dieffenbach saved my life. I was so out of it with trauma by the time that I was in Florida. Although told about what Hughes was doing, and giving her the video tapes.

she never contacted the authorities. And at the very first visit she promised me my medical records when I moved on. She never did this. I speculate that it was the serious medical and legal issues that they were going through at the time. They are good people. I was treated with great kindness, going through my horrendous traumas. Then feeling betrayed without my records, as I would have to relive and relive my trauma without professional validation.

Dr Cadena. Spring Hill FL, used to be a professor of psychiatry. He did nothing to tell the authorities.

Dr Michael Hall, Brooksville Fl. Referred this discussion to my psychologist/psychiatrist.

Dr. James Cummings, Brooksville Fl., I was told that Dr Cummings went to medical school to become a psychiatrist but didn't like it. Can't blame him. Referred this discussion to my psychologist/psychiatrist.

Dr Raghu Devabhaktuni. Hudson Fl. Dr Raghu Devabhaktuni was repeatedly told how patients were being sexually assaulted and how the authorities in NH were doing nothing. He did nothing. He would not do a write up of what I had experienced and how this effected me and how the

environments effect me. Just another pill mill in a strip mall that is unfortunately common with foreign physicians coming here.

I have met some fantastic extra ordinary surgeons and practitioners from India as well as other nations of the world. We need to weed out the slackers, incompetents, dead beats and hacks in the medical profession that harm patients and bog down the system for the true professionals.

Fontana MD was arrested, convicted of kiting, counterfeiting money over 10\$ million, served 6 years in prison. Hughes MD was arrested on 6 counts of sexual assault. He committed suicide.

I was given the wrong medicines for decades under the care of Devabhaktuni MD. I should have been given low dose, long acting benzodiazepines, along with assistance with the autism. The autism was not diagnosed, the Ehlers-Danlos Syndrome was not diagnosed. The autism was spotted/speculated with two simple questions by a psychiatrist in Bangor. Dr. Devabhaktuni, an MD, this being worthless when medicine is not practiced yet the 'drive thru' pill mill processing receiving money the practice.

Instead of doing any write ups of my traumas, or contacting the authorities when I told him about what was going on with Hughes drugging a city, sexually assaulting women and crippling my mother. I cared for since I was 27, I get print outs of medications prescribed from Devabhaktuni, no write ups.

I would have had opportunities as help for autistics as Florida has many services available. The medical literature has many articles over the past 20 years about identifying those of us who are different than neurotypicals. The 'lost generation.' We are human beings!

An analogy would not to recognize a person as being Black and missing sickle cell anemia which is an evolutionary difference created as a defense against malaria.

Instead siloed. This is not 'malpractice' this is discrimination. And discrimination comes in many forms.
